Legal Basis and processing methods

Lutech SpA processes personal data mainly on the basis of consent given by users/visitors. Consent is obtained via the browser, or when using or visiting the website, interpreted as conduct implying intent. When using or visiting the website, users/visitors approve this privacy statement and give their consent to the processing of their personal data with reference to the methods and purposes described below. Personal data are processed using automated tools (e.g. with the use of electronic procedures and media) and/or manually (e.g. on paper media) for the time strictly necessary to achieve the purposes for which they were collected, and, in all cases, in compliance with the relevant legal requirements.

Type of data processed and purposes of processing

1 NAVIGATION DATA

During their normal operation, the IT systems and software procedures which operate this website acquire certain personal data, the transmission of which is implicit in the use of Internet communications protocols. These data are used for the sole purpose of obtaining statistical (and therefore anonymous) information concerning use of the site and to check that it is operating correctly and they are deleted immediately after processing. Data concerning web contacts are not stored for more than seven days, unless required for investigations into IT crimes against the website. No data deriving from the web service are disclosed or disseminated.

2 DATA SUPPLIED VOLUNTARILY BY USERS/VISITORS

When, while connecting to this website, users/visitors send their own personal data in order to access particular services or to make email requests, the sender's address and/or other personal data are obtained by Lutech and will be processed exclusively for the purpose of satisfying the request or supplying the service required. Personal data supplied by users/visitors will only be transferred to third parties if this is necessary in order to satisfy their requests.



3 THIRD-PARTY COOKIES
